Joint Recall

Joint recall with Health Canada, the United States Consumer Product Safety Commission (US CPSC) and Ashley Furniture Industries, Inc.

Affected products

Signature Design by Ashley Amnon Floor Lamp, Model number: L207971.

Product description

This recall involves Ashley Furniture’s Amnon floor lamps with a floor switch and 12 lightbulb sockets. The portable, electric floor lamps are metal with a bronze finish and measure about 163 centimetres (64 inches) tall. Model number L207971 is indicated on the underside of the lamp’s base. The UL Certification Number is: E364368.

Hazard identified

The lamp has incorrect lightbulb wattage information printed on a label on the sockets of the lamp. The incorrect labels indicate that each socket can support 40 W bulbs, however the product is only rated for each socket supporting a 25 W bulb. The use of lightbulbs with the incorrect wattage could potentially melt the power-switch, posing a burn hazard.

As of May 25, 2018, the company has received one report of property or product damage in Canada, and no reports of injuries. In the United States, the company has received 6 reports of property or product damage from 4 consumers, and no reports of injuries.

Number sold

Approximately 106 units of the affected products were sold in Canada and approximately 900 were sold in the United States.

Time period sold

The recalled product was sold in Canada between February 2017 and April 2018.
